YAQUINA BAY YACHT CLUB CLASS
RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

(Read carefully before signing.)

In consideration of the opportunity to participate in the sport of sailing and/or kayaking and being permitted to use equipment belonging to the Yaquina Bay Yacht Club or its members, the undersigned agrees as follows:

1. The undersigned will be monitored by a U.S. Sailing Certified Instructor and/or an American Canoe Association Certified Coastal Kayak Instructor designated by the Yaquina Bay Yacht Club while using any of the equipment or facilities of the Yaquina Bay Yacht Club or its members, and the undersigned will inspect the facilities and equipment to be used and if he or she believes anything is unsafe, the undersigned will immediately advise the Yaquina Bay Yacht Club of such condition and will refuse to participate or to use the facilities or equipment until such time as the unsafe condition has been addressed. The undersigned will at all times abide by the boat loan policy of the Yaquina Bay Yacht Club and any other rules of the Yaquina Bay Yacht Club.
2. I fully understand and acknowledge that:
 - a. There are risks and dangers associated with participation in sailing school and its activities which could result in bodily injury, partial and total disability, paralysis and death.
 - b. The social and economic losses and/or damages which could result from those risks and dangers described above could be severe.
 - c. These risks and dangers may be caused by the action, inaction or negligence of myself as participant or by the action, inaction or negligence of others, including but not limited to the Yaquina Bay Yacht Club, its instructors or any of its members.
 - d. There may be other risks not known to me or which are not reasonably foreseeable by me at this time.
3. I accept and assume such risks and responsibilities for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Yaquina Bay Yacht Club or its instructors and members.
4. I hereby release, waive, discharge and covenant not to sue the Yaquina Bay Yacht Club or any of its members or directors, officers, agents, instructors, and employees from all liability to me, my personal representatives, assigns, executors, heirs and next of kin for any and all claims, demands, losses or damages on account of any injury, including but not limited to my death or the damage to property, caused or alleged to be caused in whole or in part by the negligence of the Yaquina Bay Yacht Club or any other persons above mentioned.
5. I execute this waiver and release on my own behalf freely and voluntarily. If, despite this release, I or any of my representatives make a claim against any of the persons or entities intended to be released, I agree to reimburse those persons to be released and their insuring company, if any, for any money which they have paid to defend a claim or by way of damages which may be awarded to me or my representative. I hold the Yaquina Bay Yacht Club and its representative(s) harmless from any claim or cost. **I have read the above waiver and release, understand that I give up substantial rights by signing it, and sign it voluntarily without inducement.**
