Governing Authority/Venue

YAQUINA BAY YACHT CLUB welcomes you to the Devil's Lake Revival Regatta, hereafter referred to as the RR. The RR shall be governed by the US Racing Rules of Sailing for 2009-2012 with any clarifications and/or modifications to be made prior to the start of racing. The RR will be held at Regatta Park on Devil's Lake, Lincoln City, Oregon.

Clean Regatta

We are declared a "Clean Regatta" – our pledge is to leave nothing but our wakes behind us. By participating in this regatta, each registrant is pledging to do their best to keep trash in it's place.

Registration

Eligible boats may register at the Park the morning of the race.

Sailing Instructions

Sailing instructions and a course sheet with marks, start, recall and finishing information will be provided for each boat at check-in. Fleets of 5 or more boats will have their own start.

Scoring and Trophies

The RR shall be scored according to the Low Point scoring system. One race will be thrown out for scoring purposes - except a disqualification - if 6 or more races are completed.

Liability/Insurance

Competitors participate in the RR entirely at their own risk according to RRS Rule 4, Decision to Race. Each boat shall carry safety equipment conforming to government regulations, class rules and US Sailing rules. The organizing authority will not accept any liability for material damage for personal injury or death sustained in conjunction with or prior to, during or after the Regatta. Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$100,000 per event or the equivalent.

Boat launching will be at East Devil's Lake State Park.
